

Copper/Tin Drilling Underway at Gourlays Creek




Figure 1. Stellar's west coast Tasmania tin prospects

Stellar Resources is pleased to announce that it has commenced drilling at its 100% owned Gourlays Creek copper/tin target on the northwest coast of Tasmania (see Figure 1, top left prospect).




Figure 2. SGC1 is the first of three holes proposed to test the Gourlays Creek magnetic anomaly

The target is defined by a number of intense circular magnetic anomalies over a strike length of one kilometre with a near coincident electromagnetic feature along the western boundary (see Figure 2).

Historical drilling one kilometre to the north on a weaker magnetic zone demonstrated the relationship between mineralization and magnetite skarn development. However, no previous drilling has been conducted on Stellar's magnetically more intense and more compelling drill targets to the south.

Stellar plans to drill a 400m diamond drill hole (SGC1 Figure 2) intended to pass through the centre of the magnetic anomaly and also test the electromagnetic zone.

In addition, a further two drill holes are planned along the strike length of the most intense sections of the magnetic anomaly.
